Organization:	Lyngblomsten
About:	Founded in 1906, Lyngblomsten is an award-winning Christian nonprofit organization affiliated with the Evangelical Lutheran Church of America (ELCA), providing healthcare, housing, and community services for older adults in the Saint Paul/East Metro area of Minnesota. Today our residential campus in Como Park provides short- and long-term skilled nursing care along with subsidized and market-rate senior housing with assisted living services. Our new campus in Lino Lakes offers independent living, assisted living, and memory care. Beyond the campus, our community-based programs provide supportive services to help older adults age well in their own homes in the east metro. Learn more at www.lyngblomsten.org.
Board Structure:	9–15 directors with 4 officers. Because of our organizational structure, directors serve on multiple Lyngblomsten boards concurrently. To maintain compliance with our Bylaws, 51% of our board directors must be from ELCA congregations. The work of the Board is carried out by committees and task forces.
Skills Sought:	Finance, law, technology, senior services, organizational development/strategy/change management, healthcare leadership, fundraising/advancement, or human resources
Special Needs:	In conjunction with the above-named skillsets, we are also seeking members of ELCA congregations and people with racial diversity.
Board Term:	3 years. Terms commence in May. Can renew for a second 3-year term.
Compensation:	N/A; this is a volunteer position.
Time Commitment:	Generally, 9 board meetings per year plus 1 committee meeting per month (1½ hours) or volunteer in another capacity. Occasional assignments outside of meetings. Attend the corporate annual meeting, as well as special meetings as needed. 6 of the board meetings are held via Zoom and last 90 minutes; 3 of the meetings are held in-person as 3-hour work sessions. Board meetings are usually on 4th Mondays at 5:30 PM.
Financial Commitment:	During service on the board, directors are encouraged to place the Lyngblomsten Foundation in their top charities to support financially. As an ambassador for the organization, directors are expected to share Lyngblomsten's needs and opportunities with their circle of influence, e.g., extending invitations to the annual fundraising gala.
Diversity Statement:	Lyngblomsten desires to increase the cultural diversity of our board to broaden our perspective on issues, better represent our staff and the community in which we serve, and more appropriately respond to the external influences that are changing our community and industry. We believe that diverse perspectives bolster our ability to identify the full range of opportunities and risks impacting our mission.
